# **Ethics and Malpractice Statement**

We highly encourage the authors to review and comply with the <u>COPE principles of</u> transparency and best practice in scholarly publishing.

### Authorship and contributorship policies

All persons who make substantial contributions to the preparations of manuscripts must be named in the manuscripts as co-authors. The corresponding author must be authorized by all co-authors to act as an agent on their behalf in all matters of the publication of the manuscript, and the order of names of authors should be agreed upon by all authors.

#### **Conflicts of interest**

Upon submitting their manuscripts to the journal for consideration for publication, authors must declare any conflicts of interest that may arise.

## Complaints and appeals

Authors who feel any form of discrimination linked to their submissions are requested to send an appeal or complaint email to the Editors-in-Chief. Provide a brief description of the event, a copy of your manuscript, and any supporting documentation. The Editors will check your case and will forward it to the Editorial Board of the Nordic Journal of Comparative and International Education NJCIE, who will then form an independent ethical committee to review your case. After reviewing all relevant materials and considering your consultations, the committee will send a recommendation to address the incident to the Editorial Board within one month. Based on the committee report and other relevant materials, the Editorial Board will make a final decision about your appeal or complaint.

### Data sharing and reproducibility

Upon request, authors must provide raw data related to their manuscript for editorial review.

#### **Ethical oversight**

It is the prime responsibility of authors to observe ethical principles. Consent to participate in research and final publication, ethical conduct of research on vulnerable populations, human beings, and handling confidential data must be ensured and presented in the manuscripts. Plagiarism, fabrication, falsification, citation manipulation, peer review manipulation, authorship misconduct, and other unethical practices will not be tolerated. Any breach of these and other ethical principles will be investigated by an independent ethical review committee. In addition to authors, the Editors, the Editorial Board, and the double-blind peer review system jointly guarantee ethical publication in the journal.

#### **Intellectual property**

Authors will keep their copyright and right of reproduction of their manuscripts, with the work simultaneously licensed under a Creative Commons Attribution License, but give the

journal a permanent right to 1) present the manuscript to the public in the original form in which it was digitally published and 2) to be registered and cited as the first publication of the manuscript.

This journal provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge. Submitting and publishing in the journal is free of charge for the authors.

Readers of the journal may print the manuscripts presented under the same conditions that apply to the reproduction of a physical copy. This means that mass reproduction of physical copies or production of copies for commercial purposes without the agreement of the authors is not permitted.

#### Post-publication discussions and corrections

Authors are encouraged to promote and disseminate their publications and can use them for research, teaching, and scholarly purposes. Provided that appropriate credit is given to the journal, authors may also republish their articles in any subsequent book, article, or other scholarly work of which they are authors,

The journal has signed up for the PKP Preservation Network (PKP PN) which uses the LOCKSS program for decentralized distributed digital preservation. This ensures continued access to the journal's content in the event of a catastrophic failure or if the journal is no longer published and removed from the web. In these cases, the content can still be made available again by the PKP PN.

Authors are required to notify the journal editors when they discover significant errors or inaccuracies in their own published works. The Editors will ensure retractions or corrections of mistakes as soon as possible.
